



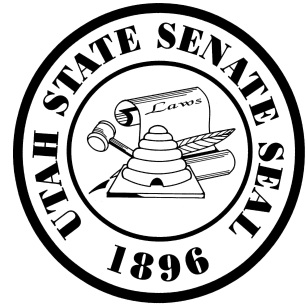

UCA 36-12-13(2)(c)

To the extent that a local education agency has not already incorporated policy development into its school board's regular administrative duties, enactment of this legislation could result in an estimated one-time cost of \$1,500 to \$4,000 in FY 2027 to develop and adopt the policies required by the bill.

Individuals & Businesses

UCA 36-12-13(2)(c)

Enactment of this legislation likely will not result in direct expenditures from tax or fee changes for Utah residents and businesses.

Notes on Notes

Fiscal explanations estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal explanation is not an appropriation. The Legislature decides appropriations separately.
